-When you have chosen which type and how much Cryptocurrency you wish to buy, you will be shown what the relevant exchange rate is. Please note that the exchange rate is recalculated very often. You will be able to see the accurate exchange rate at all times during the conclusion of the transaction.

-Once you have indicated how much and which type of Cryptocurrency you wish to buy, you will also be shown the fee for carrying out the Purchase.

-You will be asked to indicate your wallet address to proceed with the Purchase.

-You will be able to check the details of the Purchase all the time before the Purchase is finalized, using the drop-down.

-Your email address will be the main credential when logging in to use the Service.

-If, after providing us with your email address, we see that you do not have a profile yet, you could be asked to go through our KYC procedure. GoGateway.io must carry out a KYC procedure due to obligations arising from applicable anti-money laundering (AML) related legal acts. You may only register once.

-The user will be asked to indicate its credit card details. You will also be asked to provide Third Party Payment provider used by GoGateway.io with your billing address, email and identity document. To enable us to verify the document, you will be asked to take and upload a photo of yourself (selfie). You must also provide us with a proof of residence. Instructions for this will be given on the screen.
